URGENT NOTICE

TO ALL BUSINESSES...

You could be held responsible for spot fines, company down time, staff short time and business suspension of civil prosecution should your company not be fully compliant and up to date with your Health and Safety Risk Assessments, training and courses, audits or firefighting protection or if your employees get injured whilst at work.

THREE Facts you should know about the employers' duties with regards to the Occupational Health & Safety Act No. 85 of 1993

- 1) Every employer shall provide and maintain, as far as is reasonably practicable, a safe working environment that is without risk to the health of his employees.
- 2) Without derogating from any specific duty imposed on an employer by this Act, every employer shall as far as is reasonably practicable, cause **every employee** to be made conversant with the hazards to his health and safety attached to any work which he has to perform, any article or substance which he has to produce, process, use, handle, store or transport and any plant or machinery which he is required or permitted to use, as well as with the precautionary measures which should be taken and observed with respect to those hazards;
- 3) Subject to the provisions of subsection (2), every employer who has more than 20 employees in his employment at any workplace, shall, within four months after the commencement of business, or from such time as the number of employees exceeds 20, as the case may be, designate in writing for a specified period **health & safety representatives** for such workplace, or for different sections thereof.

The Occupational Health and Safety Act requires every employer to provide where reasonably practicable, premises that are free of hazards and risk to any person working on or visiting their premises.

Proof of certain facts must be available in order to prove due diligence in the event of an inspector visiting your premises, or at worst a guest or employee is injured on your premises.

Should you not be able to prove due diligence, you could be **DENIED** payment from your public liability insurer, thus costing you in terms of recovering from financial and bad publicity losses
